undeveloped land. <u>Threats</u> discussed were capital availability, AI, infrastructure, shoreline development and hazard areas, campgrounds, lack of investment in our community.

- A. Community Survey The planning commission will not issue a community survey to generate public input. Factors leading to this decision include: a wealth of information and ideas has already been provided both at this meeting and at previous meetings, the response rate for surveys is low, a survey is not likely to produce additional or different input, the cost of a survey is significant.
- B. Master Plan -- Asset management will be included in the master plan. This master plan is to set goals and objectives, not to adjust zoning. Master plan is scheduled to be ready in early spring. Drafts will be posted on the Baraga Township website. A public work session will be held before the master plan is adopted, on Monday, March 10, 6:00 PM. Sections (1), (2), (3) no changes and will be posted on the website, drafts to (4) and (5) were provided tonight and will be posted on the website, drafts to (6), (7), (8), (9), (10) will be ready before the March 10 work session. At this work session the planning commission will review and forward any changes to Jason McCarthy and will adopt
