The Baraga Township Planning Commission will be holding a public hearing on Wednesday, July 8, 2026, at 6:00 pm at the Baraga Township Hall located at 13919 State Hwy M-38, Baraga, MI 49908. At this meeting, the Planning Commission will be hearing comments concerning a Special Land Use Permit Application.

The combined 18.49 acres is described as:

A parcel land being a part of Government Lots 1 and 2 of Section 2, Township 52 North, Range 33 West, Baraga Township, Baraga County, Michigan, described as: Commencing at the North Quarter corner of said Section 2; thence N. 89° 59' 54" E. 790.91 feet along the North line of said Section 2 to a point on the Easterly right of way line of Highway U.S. 41; thence S. 19° 29' 36" W. 768.63 feet along the Easterly right of way line of said Highway U.S. 41 to the point of beginning of this description; thence continuing S. 19° 29' 36" W. 636.83 feet along the Easterly right of way line of said Highway U.S. 41; thence S. 89° 42' 50" E. 299.61 feet; thence S. 19° 26' 24" W. 352.23 feet; thence N. 70° 30' 02" W. 283.75 feet to a point on the Easterly right of way line of said Highway U.S. 41; thence S. 19° 29' 36" W. 149.72 feet along the Easterly right of way line of said highway U.S. 41; thence S. 70° 28' 52" E. 283.60 feet; thence S. 19° 32' 19" W. 293.05 feet; thence N. 70° 34' 32" W. 283.37 feet to a point on the Easterly right of way line of said Highway U.S. 41; thence S. 19° 29' 36" W. 50.00 feet along the Easterly right of way line of Highway U.S. 41; thence S. 70° 34' 32" E. 283.43 feet; thence S. 83° 40' 06" E. 460.31 feet to a point on an intermediate traverse line along the shore of Lake Superior; thence along an intermediate traverse line along the shore of said Lake Superior the following three courses: N. 21 ° 15' 47" E. 238.15 feet; thence N. 14° 55' 09" E. 644.90 feet; thence N. 16° 11' 49" E. 512.54 feet; thence leaving said intermediate traverse line N. 89° 42' 50" W. 345.84 feet; thence N. 70° 33' 01" W. 331.00 feet to the point of beginning of this description.
